The use of investigative tools and methods and their proper application is emphasized.2. An introduction to field investigation, including conduct at the crime scene, interviewing and interrogation of witnesses and suspects, the use of informants and techniques of surveillance. Emphasis is placed on special investigative techniques and on court procedures of the police case.3. The teaching methodology is lecture and the application of the course or any part to current, relevant issues. Student participation via discussion or exhibition of investigative technique will be required.4. Fundamentals of Criminal investigation is not limited	<ol style="list-style-type: none">1. This course deals with the use of inductive and deductive reasoning.2. The students must know the major steps in Preliminary Investigation and Follow-Up Investigation.3. The importance and steps of the crime scene search are examined. The care and custody of physical evidence is also examined.4. The students must be able to distinguish class characteristic evidence from individual characteristic evidence.5. The types of physical evidence and how they are used in criminal prosecutions.6. In a society of computers and data banks, the individual ability of an investigator remains as the ultimate tool of agencies seeking not only answers, but proof. This course is designed to invoke in the student his/her problem solving ability and, in so doing, expose him/her to the interactions between the criminal, the police, and our judicial system and the ultimate result on society.</p> <p>6. A related aspect of the course is that concerned with exculpatory evidence on that which is pertinent to the proof of innocence. These crimes include homicide, sex offenses, robbery, burglary, larceny, arson, and narcotics. This includes the use of physical evidence, documents and testimony, especially as it relates to these crimes.</p> <p>10.
