Course Description, Prerequisite, Corequisite:

NUR-224 provides a collegial environment through which the student has an opportunity to critically analyze and debate pertinent issues in nursing and health care relevant to transition into professional practice. Issues in professional practices are addressed including quality initiatives, legal and ethical responsibilities, politics in nursing, and civility in the workplace. Practice frameworks are utilized to empower the student to advocate for safe, effective, equitable, and timely patient care. Prerequisites: NUR-101, NUR-124, BIO-231, ENG-101, PSY-101, NUR-121, NUR-204, BIO-232, PSY-210, NUR-201, BIO-235, SOC-101. Co-Requisites: NUR-221, ENG-102, Elective (The College has renumbered and relabeled all courses. Consult with the Registrar's Office for questions regarding prior course numbers.)

Course – Program Outcomes/Competencies

Course Outcomes: At the completion of NUR 221, the student will demonstrate Nursing Knowledge by achieving the following nursing competencies:

- 6. Identifies systems factors that facilitate or interfere with effective team functioning. (Teamwork and Collaboration).
- 7. Describes approaches for improving processes and outcomes of care Same as above.. (Quality Improvement).
